Please read the terms and conditions carefully and sign it below:

1. Membership in Bhutanese Community Association of Akron Inc., (hereinafter also referred to as “the BCAA” or “the Association”) is completely voluntary, and individuals must submit a membership application along with the required dues to become a member.
2. Submission of membership application forms and appropriate dues alone does not constitute approval of membership. Membership registration is considered complete only upon receipt of written confirmation from BCAA via mail or email.
3. Members are expected to conduct themselves in a manner that aligns with the social and moral norms of society
4. Members must respect the rights of other individuals’ members, including but not limited to, those related to gender equality, race, ethnicity, religion, political beliefs, language, sexual orientation, and socio-economic status
5. Member must agree to pay the annual dues established for its Membership Class, as may be amended from time to time in accordance with the Bylaws. Dues are yearly and payment is required upon signing (to activate membership) and upon renewal (on the anniversary of membership activation). BCAA will send a bill for dues in advance by written notice invoice, and payment will be due within 30 days of mailing. Life members’ dues are onetime payment.
6. Members agrees to abide by, and shall have all applicable rights and responsibilities set forth in the Bylaws, policies and procedures(P&P’s) adopted by BCAA, as any of these may be amended from time to time, all of which are hereby incorporated by reference (the “BCAA P&P’s”)
7. The BCAA board, shall have the right to discipline, suspend or terminate membership if it violates any of the BCAA’s Bylaws provision, its policies & procedures or engages in conduct that seriously prejudicial to the Mission, Vision, Purpose, and Objectives; and fails to reasonably correct that breach within 30 days of notice from BCAA. No refunds of Membership dues or other payments will be done for suspension or termination.
